**REPRESENTATION.**

We thank you for your letter of 27th January offering us the representation of your interests here effective from end of the current month.

With pleasure we inform you we shall be agreeable to accept your offer and apart from sending us your Book of Rules embodying lists of entered vessels we do not think we require any further information. We take it that fees to be charged will be based on the amount of work involved in each case which is the system we work upon with the other Associations we already represent, however should you have any set fees we shall be obliged if you will send us a list for our guidance.

Would you please clarify with Messrs. Barbosa Caravia whether they have any unclosed cases and, if so, whether they will attend to them until completion, failing which that they hand over all relevant documents to us. At the same time should they not wish to become involved in any new cases which may arise between now and the end of February we have no objection to attending to them although officially our representation does not commence prior to 1st March 1961.
